MINUTES

MINUTES: Introductions were not needed. Bruce reviewed the agenda and encourage participation. Elementary schools successfully reopened to five days a week commencing April 19 and following an almost typical daily schedule. JM started Monday (4/21), five days a week with longer periods. Bruce noted it is an exciting time with about 85% of students returning, a number that for now is increasing. He also noted FDL classes continue and he thanked the Board, administrators, teachers, classified staff and parents for their support as we transition to new schedules.

- 4) Expanded Learning Opportunity Grant per AB 86
 - a) Seeking Input re: Expanded Learning Opportunities Grants (Background) To be eligible for funding, LEAs must implement a learning recovery program, that at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to specified student groups, as defined in Education Code Section 43522, who have faced adverse learning and social-emotional circumstances. ELO Grants shall be expended only for any of the following purposes: extending instructional learning time, accelerating progress to close learning gaps, integrated pupil supports, community learning hubs, supports for credit deficient pupils, additional academic services, and training for school staff.

MINUTES: Bruce explained the ELO Grant and that the MSD is seeking input from CC members, staff and parents regarding ELO programming for summer and next school year. He noted the survey where input can be offered. CC members offered the following input: multi-sensory instruction and movement breaks; keeping the 6th grade Where Everyone Belongs day and Safe Schools Ambassadors program (on current initial budget reduction list) and to increase financial support for both programs; can MSD include music and PE or other enrichment programs in the summer school schedule.

MINUTES: Bruce presented eight slides reviewing the LCAP format – from goals to state priorities to measurable outcomes to action. CC members were divided into four breakout groups to review, edit or offer new goal recommendations. After breakout sessions, each group reported suggestions or recommendations to the CC. Feedback ranged from combining goal elements, to adjusting existing language to adding new language. Feedback will be presented prior to the next CC meeting
