This Elementary and Secondary School Emergency Relief Expenditure Plan (ESSER III) was developed with input and/or meaningful consultation with students, and families (including families that speak languages other than English), school and district administrators (including special education administrators), teachers, principals, school leaders, other educators, school staff, and local bargaining units, as applicable. This includes community input gathered for the development of the following three plans of our LEA: 2021-24 Local Control Accountability Plan (LCAP), Expanded Learning Opportunities Grant Plan (ELO) and this ESSER III. Stakeholder engagement is primarily accomplished by means of a representative body, the district Coordinating Council, which includes teachers, students, union representatives, parents (include ELL and students with disabilities), classified staff, PTA,

administration, school site council representatives, the Moraga Education Foundation and the governing board. Coordinating Council meetings provide all stakeholders an opportunity to provide feedback, which is then discussed, and, when appropriate, used to edit LCAP sections. Principals collected feedback from site classified and certificated staff and parents. The district sends notification to all parents and staff to provide input via a dedicated "LCAPfeedback@moraga.k12.ca.us" email address. Opportunities for input were also available during governing board meetings. At least twenty-nine opportunities were provided for input via newsletter and or meetings. MSD's Coordinating Council met five times (3/24; 4/14, 4/21, 5/4, and 5/12). The survey was conducted 3/9 through 3/16, and on 3/24. Information about opportunities were published in school and district newsletters on 3/5, 3/12, 3/13, 3/14, 3/15, 3/23, 3/24, 4/18, 4/25. A draft LCAP was posted on the MSD on 5/27. Information and input opportunities were offered at site PTA meetings, PTA Executive Board meetings and PTA CORE meetings on 3/3, 3/24 and 3/28. LCAP information was presented formally at the 4/13 governing board meeting to provide background and to encourage participation and input into the process of developing the LCAP. The Leadership Team addressed the LCAP on 2/23, 3/9, 3/23 and 5/3. The Moraga Education Foundation received LCAP information and provided input at meetings held on 3/5, 3/16, 3/19 and 4/23.

The ESSER III plan has been strategically coordinated with other federal Elementary and Secondary Emergency Relief Funds received by the District. This process includes expenditure planning development of all funds with the Superintendent, Chief Business Official, District, leadership team, staff and Governing Board. The expenditure of these and other coordinated federal funds is strictly monitored by the Chief Business Official.

#### A description of how the development of the plan was influenced by community input.

The Actions in this ESSER III are greatly impacted by the input gathered by our community. The gathered input is summarized below under three categories: Implementing Strategies for Continuous and Safe In-Person Learning, Addressing the Academic Impact of Lost Instructional Time, and Using Remaining Funds for Additional Actions to address students' academic, social, emotional, and mental health needs, as well as to address opportunity gaps.

##### Implementing Strategies for Continuous and Safe In-Person Learning

MSD has recently upgraded heating, ventilation, and air conditioning (HVAC) systems. In order to maintain an effective environment for learning and the wellness of students and staff, all HVAC are equipped with MERV 13 filters. These filters are changed monthly and come at a cost to the District. Additionally, PPE is required for students to fully participate in music and is essential to maintaining compliance with state and county mandates.

##### Addressing the Academic Impact of Lost Instructional Time:

MSD is offering both math and ELA instructional support programs.

##### Using Remaining Funds for Additional Actions

Safe in-person learning requires ongoing updates to technology in MSD. One-to-one devices were required for students during distance learning and need to be replaced to ensure adequate technology to support in-person learning.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
